- The HPL Board approved the motion made by Bellamy Schmidt and seconded by George Mettey "...to select Harpswell Investment Management as the new investment management firm for the Library...".
- Bellamy Schmidt shares the Holyoke Public Library section of the of the city budget. The City Council cut salary adjustments for the library. Many HPL people have not received raises for an unreasonable time.
- The President of the City Council has asked Bellamy as city auditor to look at the salaries and reports
